- **Finance Committee:** Nancy is arranging a meeting of the finance committee to review the District's financial standing, financial policies and FY 16-17 Budget.

- Marin Coastal Permit Coordination Program There are fifteen projects included the 2016 Marin Coastal Permit Coordination Program which is to be posted in the Point Reyes Light and Marin RCD website this week. The list is open for public comment before the projects are formally approved at the June meeting.
- Marin Carbon Project The State Conservancy Seq-C Soil Report is complete!! A soil monitoring field day for RCD/NRCS staff is being organized for May 12th. One carbon farm plan is in progress and the second will be executed in mid-April. MCP has met with Gov Brown Senior Advisor and Director of Planning and Research. MCP team also met with NRCS Chief James Weller. New maps developed: carbon farming in Marin and CA.
- **Black Mountain Roads** Tasks left in contract: fencing and minor erosion control work.
- **Urban Streams Coordinator** The USC conducted four site visits and assisted a multitude of residents and stakeholders when a site visit was not necessary. The USC attended two conferences and one workshop regarding salmonid restoration, water conservation and fine sediment reduction entering Marin's creeks (see USC report).
